

Official Rules: A-RI Productions x Tika Creations Headshot Giveaway

1. Eligibility

- **Who can enter:** This giveaway is open to aspiring or professional actors who are **18 years of age or older** at the time of entry.
- **Session Location Requirement:** Winners **must be able to travel to a professional studio in Austin, Texas**, for the headshot session. The specific studio will be booked and communicated by Tika Cook.
- **Travel Costs:** All costs associated with travel to and from the chosen studio location in Austin, Texas (including, but not limited to, airfare, ground transportation, accommodation, meals, etc.) are the **sole responsibility of the winner**.
- **Actor Focus:** Entrants must be aspiring or professional actors seeking a headshot for their theatrical or commercial acting career.
- **Void Where Prohibited:** This giveaway is void where prohibited or restricted by law. Employees of A-RI Productions, Tika Creations, their immediate family members, and affiliates are not eligible to enter or win.

2. Giveaway Period

- **Submission Deadline:** All entries must be submitted by **July 19, 2025, at 11:59 PM CDT**.

3. How to Enter

Entering is easy and gives you multiple chances to win! Participants can earn up to five (5) entries in total:

1. **Submit the Entry Form:** Complete and submit the official giveaway entry form [**Insert Link to Form Here**].
 2. **Follow A-RI Productions:** Follow **@A_Ri_Productions** on Instagram.
 3. **Follow Tika Creations:** Follow **@Tika_Creations** on Instagram.
 4. **Like This Post:** Like the official giveaway announcement post on Instagram.
 5. **Tag Two Actor Friends:** Tag two (2) actor friends in the comments of the giveaway post.
 6. **Share to Your Story (Bonus Entry):** Share the giveaway post to your Instagram Story for one (1) extra entry, and make sure to tag **@A_Ri_Productions** and **@Tika_Creations** so we can see it!
- **Entry Limit:** Participants can enter using one (1) email or Instagram account. Submitting multiple entry forms or using multiple email/Instagram accounts will result in disqualification.

4. Prize

- **Prize Details:** **Three (3) winners** will each receive one (1) professional acting headshot package with **Tika Cook of Tika Creations** at a **professional studio in Austin, Texas**.

Tika Cook will be responsible for booking the venue for the headshot session. Each prize package includes:

- A **roughly 1-hour photoshoot session**.
- **2 distinct "looks"** (outfit changes/styles).
- Review of **100-120 watermarked images** from which to select.
- **3 expertly retouched digital images** of the winner's choice.
- **Professional hair and makeup application** for the session.
- A consultation with Tika Cook to discuss desired looks and typecasting.
- **Exclusions:** The prize explicitly *does not* include any travel, accommodation, per diem, or other expenses related to the winner attending the headshot session in Austin, Texas. These costs are the **sole responsibility of the winner**. Additional retouched images beyond the three included may be purchased separately by the winner directly from Tika Creations at their standard rates.
- **Prize Value:** The approximate retail value of each headshot package is **\$500** (session value \$350 + hair/makeup \$150).
- **Non-Transferable:** The prize is non-transferable, and no cash alternative will be offered. The prize cannot be substituted, exchanged, or redeemed for cash.
- **Expiration:** Winners must book and complete their headshot session within **30 days** of notification.

5. Winner Selection and Notification

- **Drawing:** The three (3) winners will be selected at random from all eligible entries received on **July 23, 2025**.
- **Winner Announcement:** Winners will be announced via the **@A_Ri_Productions Instagram page** and the **A-RI Productions website** on **July 23, 2025, at 5:00 PM CDT**.
- **Notification:** Potential winners will also be notified directly via **email**.
- **Claiming Prize:** Each potential winner must respond within **72 hours** of notification to claim their prize. If a potential winner does not respond within the specified timeframe, is found to be ineligible, or declines the prize for any reason, an alternate winner may be selected.
- **Publicity:** By accepting the prize, winners grant A-RI Productions and Tika Creations permission to use their name, likeness, and social media posts related to the giveaway for publicity and promotional purposes without further compensation, unless prohibited by law.
